

## Executive Summary

The Bid Evaluation Committee met to submit its report and recommendation for the award of the contract for the "Supply, Testing and Commissioning of Compactor trucks, Tipper Trucks, Vacuum Road Sweeper Trucks, Trucks Mounted Combination Jetting Vacuum Unit 6000 L and Trucks mounted with telescoping Aerial Lift and Working Basket" for the Ministry of Local Government and Disaster Risk Management.

The Procurement method used was International Open Advertised Bidding on 27 October 2022. The closing date of the bids was 17 January 2023 and Opening of Bids was 19 January 2023 at 14.01 hours. A list of addendum issued on 10 January 2023. The Bids were valid for 90 days and bid security for 120 days and both have been extended.

Bids without bid security will not be considered

Five Bids were received namely, Toyota (Mauritius) Ltd, ABC Motors Ltd, Axess Ltd, Paragon Motors Ltd and CFAO. As Toyota (Mauritius Ltd) did not submit its bid security hence, its offer was not considered for evaluation.

The Bids were examined by the Bid Evaluation Committee and made its recommendations for award of the contract as follows:

### **Paragon Motors Ltd for:**

**ITEM 1:** Supply, Testing and Commissioning of 7 units of Trucks Mounted with Compactor of Capacity 6.0 -7.0m<sup>3</sup> for the sum of Rs 20,377,000, exclusive of VAT and Rs 414,441.26, maintenance cost, inclusive of VAT; an

**ITEM 2:** Supply, Testing and Commissioning of 14 units of Trucks Mounted with Compactor of Capacity 12.0 -13.0m<sup>3</sup> for the sum of Rs 48,216,000 exclusive of VAT and Rs 488,443 maintenance cost, inclusive of VAT.

### **Axess Ltd for:**

**ITEM 3:** Supply, Testing and Commissioning of 5 units of Tipper Trucks of Capacity 12.0 -13.0m<sup>3</sup> for the sum Rs 17,653,741 exclusive of VAT and Rs 112,000, maintenance cost inclusive of VAT.

### **Paragon Motors Ltd for :**

**Item 4:** Supply, testing and commissioning of 19 units of Tipper Trucks of capacity 16.0 – 17.0 m<sup>3</sup> for the sum of Rs 42,636,000 exclusive of Vat and Rs 451,886, maintenance cost inclusive VAT.

**Axess Ltd for :**

**Item 5:** Supply, testing and commissioning of 2 units of Vacuum Road Sweeper Truck, Complete with accessories for the sum Rs 26,167,900 exclusive of VAT and Rs 436,000 maintenance cost inclusive VAT

**Item 6:** Supply, testing and commissioning of 2 units of Truck Mounted combitional Jetting Vacuum Unit 6000 Lts for the sum of Rs 31,817,300 exclusive of Vat and Rs 374,150 maintenance cost, inclusive of VAT.

**CFAO Ltd for:**

**Item 7:** Supply, testing and commissioning of 10 units of Truck Mounted with telescopic Aerial Lift & Working Basket for the sum of Rs 38,445,600 exclusive of Vat and Rs 162,826 maintenance cost inclusive of VAT.
