3. The vehicles should be delivered **within 240 days** as from the date of this Letter of Award.
4. You are requested to submit within twenty-eight (28) days as from the date of this letter a Performance Security representing 10% of the contract value in the form of a Bank Guarantee issued by a Commercial Bank operating in Mauritius. The Security should be valid for a period of twenty-eight (28) days beyond the warranty period which takes effect after the commissioning of the vehicles and should be submitted to the Confidential Registry, Ministry of Local Government and Disaster Risk Management, 3<sup>rd</sup> floor, Emmanuel Anquetil Building, Port Louis. In the event of delay in the delivery and/or commissioning of the vehicles, you shall agree to an extension of this security for the period mentioned above.
5. Payment will be made into your bank, by the Procurement and Supply Section, Ministry of Local Government and Disaster Risk Management, 10<sup>th</sup> Floor, Emmanuel Anquetil Building, Port Louis, upon confirmation by Local Authorities that the vehicles have been delivered, tested and commissioned satisfactorily and are in good running conditions.

6. The following documents should be submitted for payment purposes:
- Duly signed Goods Form No.1
  - Duly Signed original delivery note
  - Duly Signed original invoices
  - Warranty and commissioning certificate
  - Documentary evidence certifying payment of VAT and
  - Your bank name and bank account number.
7. Liquidated damages shall be 1% of contract price per week of delay of the undelivered goods. The maximum amount of liquidated damages shall be 10% of the contract price of undelivered goods, after which the contract shall be considered as terminated.
8. Warranty shall be at least two (2) years following testing and final commissioning of the trucks. For purpose of warranty, the places of final destination shall be Local Authorities in Mauritius.
9. You should provide ten (10) hours of training at no additional cost, to the Ministry's representative's personnel, viz Drivers, Operators & Mechanic about the proper operation of Trucks by a qualified trainer.
10. You may also wish to note that the vehicles will be allocated to the Local Authorities. As such, they may enter into maintenance contract as follows:
